- 1. A map or diagram must be provided by the applicant showing the area where the party will be held and all Streets in the area that may be affected.
- 2. The Applicant must provide a petition, signed by all homeowners within the blocked off area indicating that they have been advised of the closing of the street(s).
- 3. The area involved MUST be barricaded to restrict traffic flow; however, a responsible and able bodied person must be available at all times to remove the barricades in case of an emergency. EMERGENCY FOUIPMENT MUST HAVE IMMEDIATE ACCESS should the need arise.
- 4. The street may be used for tables, games, etc. on the condition that ONE LANE is maintained with NO large objects or cumbersome to move items, which could potentially limit emergency equipment/vehicle access.
- 5. If alcohol is being served, it should only be served from ONE location and an adult must be present at all times to insure that no one is serving minors or intoxicated persons.
- 6. The area used must be returned to its "pre party condition" with all litter, recyclables, etc. disposed of properly.
- 7. All Village Ordinances MUST be adhered to.

I hereby accept the rules and regulations noted above and hold the Village of North Syracuse harmless from any liability associated with the event listed on the other side of this permit. I also accept responsibility for any and all violations and damage that may occur as a result of this event.
