It shall be a precondition that any person intending to go door to door in the Village of North Syracuse obtain a permit from the Village Clerk Treasurer, and comply with the Village Code. You will be required to show this permit to each resident or official upon request.

BEFORE A PERMIT IS ISSUED EACH APPLICANT MUST:

1. Pay a \$50.00 fee for a licensing fee and \$10.00 for a background check. **Cash or money order, NO PERSONAL CHECKS** accepted.
2. Each applicant must sign an Authorization for background check, and provide a legible copy of their driver's license or other State or Government issued photo ID. **This is a ONCE per year fee.** *It is your obligation to inform the Village Clerk Treasurer of any convictions after the date of the background check.*
