

The survey indicated that the educational program can be strengthened by intensifying pet waste management messages, identifying new electronic outlets incorporating social media; and continuing to emphasize stormwater pathways and the economic benefits of not using phosphorus fertilizer on residential lawns.

The CNY Stormwater Coalition website was continuously updated and promoted as an informational resource; usage was up again during the 2018-19 permit year.
