He continued he wants to sell his business; he has customers that want to buy the business and take over and maybe change the name. Germain, himself, and Mrs. Fuller, because it is complicated. He stated he would like to make this business friendly if possible. He continued why can't we change the Code to Allow Motor Vehicle Repair, not Motor Vehicle Sales, just repair in a C-3; then they do not have to get a Special Use Permit, he believed. He added Atty. Germain worked up the change, we did this recently, we had another change similar; to make it a little more friendly to businesses. Dep. NORTH SYRACUSE HOUSING AUTHORITY: OVERVIEW/CURRENT STATUS/AUDITORS/HUD

The Mayor stated next on the agenda is North Syracuse Housing Authority: Overview/Current Status/Auditors/ Hud: As we have been aware, we were informed in a few different meetings that there were some issues, some deficiencies and he is here to get an update from Bob Weismore, Exec. Dir. The Mayor continued the North Syracuse Housing, is not part of the Village of North Syracuse. He added, but we do sponsor it, so; if anything happens, we get included and there were some issues we became of aware of. Mr. Weismore discussed: Work experience, HUD coming next week, audit with Bonadio; where they have gotten so far and the gap of time, they need to fill in. Program cannot work remotely as with Covid, HUD changing constantly, so cannot get behind. He will provide a list of identified items from the audit to the Board and report back at the next meeting Board meeting after they meet with HUD. The Mayor stated we, they did not really know much nor did he, you are a separate organization from the Vlg. He continued based on what he had heard, we are breathing easier now, and not in danger of; it was bad. He continued we are going to get this all straightened out.

RE-EVALUATE 215 HERMAN DRIVE-TRIM TREE/REMOVE

The Mayor stated the next item on the agenda is to re-evaluate 215 Herman Drive: Discussion went back and forth regarding: DPW Sup't. Ware did measure, it is 5' within the right-of-way, it is far enough away from the intersection; that he does not see it hindering traffic. WHEREAS, a Project for the TAP 2022 Pedestrian Improvements, Village of North Syracuse P.I.N. 395081 (the Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 80% Federal funds and 20 % non-federal funds; and

WHEREAS, the Village of North Syracuse desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of Engineering, ROW and Construction.

NOW, THEREFORE, the Village of North Syracuse Board, duly convened does hereby

RESOLVE, that the Village of North Syracuse Board hereby approves the above-subject project; and it is hereby further

RESOLVED, that the Village of North Syracuse Board hereby authorizes the Mayor of the Village of North Syracuse to pay in the first instance 100% of the federal and non-federal share of the cost of Engineering, ROW and Construction work for the Project or portions thereof; and it is further

RESOLVED, that the sum of \$1,558,200 is hereby appropriated from the General Fund and made available to cover the cost of participation in the above phase of the Project; and it is further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the Village of North Syracuse Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Board thereof, and it is further

RESOLVED, that the Mayor of the Village of North Syracuse be and is hereby authorized to execute all necessary Agreements, certifications or reimbursements requests for Federal Aid and/or Marchiselli Aid on behalf of the Village of North Syracuse with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share for federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and it is further

RESOLVED, this Resolution shall take effect immediately.
