Good Morning Gordon,

Please see our review attached, including the following conclusion:

1. A revised TIS addressing the signal timing errors (explained in the review) is needed; updating the LOS and queue length, and correcting the available storage discrepancies. Additional comments may follow.

2. Ingress from E. Taft Rd is prohibited.
3. Right-out egress on E. Taft Road must be designed to restrict lefts-out.
4. Defer to OCDOT for S. Bay Road access.
5. Due to the potential to generate pedestrian traffic to the site, two new pedestrian crossings must be installed at the intersection of US11 @ E. Taft Rd; one across the eastern and one southern approach. This signal is already equipped with video detection. Adjusting pavement markings to install crosswalks will not require detection modification.
6. Sidewalk along the Route 11 frontage is required to accommodate pedestrians generated by the development and for future connections to the south.
