As required by the New York State General Municipal Law, the Village of North Syracuse hereby notifies you of a pending project that is located within 500' of the municipal border of the Village of North Syracuse, and Town of Clay.

Please be advised under the Village of North Syracuse Code, the property located at 306 S. Main St., Ste. #5 (Tax ID. No. 003.-08-13.1) owned by North Syracuse Plaza, LLC., which is zoned C-1 (Business). We have taken in an application from F & A FASTFOOD, Albadri Group, LLC. (Anmar Adnan), which have proposed a takeout restaurant only to go in a vacant space, there will not be a drive thru, and have asked to appear before the Planning Commission for Site Plan Review and Approval with Special Permit. As per §240-11 B. (6) Restaurant/bar requires an issuance of a Special Permit. No exterior site work is proposed.

The Village Planning Commission shall conduct a 2<sup>nd</sup> meeting to review the proposal on December 18<sup>th</sup>, 2025 commencing at 5:30 PM and to be held at the North Syracuse Community Center at the corner of South Bay Road and Centerville Place in the Village, unless otherwise specified. They will offer: American Fastfood, no tobacco or alcohol will be served.
